- I would be grateful if you could complete (ONLINE) the <u>student admission form</u>, the <u>guardianship</u> form and <u>declaration form</u>, sign and submit. Please note that offer of admission remains pending until we receive these completed forms. Further please click and download <u>Parent Affidavit form</u>, <u>Indemnity Letter form</u>, <u>Undertaking form</u> and <u>Student Health Record Form</u>. These duly filled forms should be submitted at the time of reporting to the school along with the supporting documents. Please also forward the original school leaving certificate when it becomes available from the current school. However, the date of submitting the TC, Birth Certificate & Report Card of the child shall be considered as the Admission date of the child.
- > The new students will be required to report on Tuesday, April 01, 2025.
- Please do note that once the Contribution Amount is paid, incase of withdrawal due to any reason, the Admission fees will be non-refundable.

- 10. Affidavit by the Parents To be on a Rs.10.00 Non-Judicial Stamp paper and Notarized by a Notary.
- 11. Indemnity Letter To be on a Rs. 10.00 Non-Judicial Stamp paper and notarized by a Notary.
- 12. Undertaking To be on a Rs. 100.00 Non-Judicial Stamp paper and notarized by a Notary.
- 13. Health Record Form Student must be examined by an MBBS Doctor. The Health form should have doctor's signature and seal over it.
- 14. Caste Certificate (if applicable)
- Please be informed that a child would be admitted only after the verification of all the submitted documents. If, at the time of checking, any discrepancy is found in any document of the child or if the School Management is not satisfied, the admission of the child shall stand cancelled. Deduction of the admission charges from the deposited amount shall be made before its return.
- For class XI kindly note, admission is provisional till the class X Mark sheet and required documents are submitted.
